2 part catalyzed Acrylic Urethane coating. The 97 series offers easier application and faster dry along with better flow. This product is characterized by extreme exterior toughness and durability. Note: this may only be used with AH-2 Acrylic Urethane Hardener.

Surface Preparation

Apply over properly prepared surfaces. Ensure that any primers or sealers used are suitable for urethane coatings. Ensure that any primers used are lift resistant. Surface must be clean and free of dirt, grease and water. No Maclac paint product has ever contained any lead. But if you are preparing previously painted surfaces with unknown paints please observe the following precautions. Warning! If you scrape, sand, or remove old paint, you may release lead dust. LEAD IS TOXIC. EXPOSURE TO LEAD DUST CAN CAUSE SERIOUS ILLNESS, SUCH AS BRAIN DAMAGE, ESPECIALLY IN CHILDREN. PREGNANT WOMEN SHOULD ALSO AVOID EXPOSURE. Mixing & Thinning

This product must be catalyzed at the rate of 4:1 by volume with the AH-2 Acrylic Hardener. Mix 4 parts of the base to 1 part of the hardener. Optimum pot-life after catalyzing is 2 - 4 hours. Note: the pot life will vary depending on temperature and mixing conditions. Higher temperatures and prolonged mixing will shorten pot life. No thinning is recommended, however if thinning is desired - use Acetone (which is EPA exempt) in California, and urethane grade thinners elsewhere.

NOTE: Thinning with non-exempt solvents will increase VOC. Thoroughly mix the material by stirring or shaking prior to application.

Application & Dry

This Acrylic Urethane coating is designed for spray application only. The best appearance will result if the mixed material is applied within the first hour after catalyzing. Application after the catalyzed material has begun to thicken will result in an orange-peel appearance.

This Acrylic Urethane may be applied with conventional, airless, air-assist airless or HVLP spray equipment. Follow the equipment manufacturers recommendations for adjusting spray patterns. A light wet coat followed by a full coat is recommended. The best time to recoat for building the film thickness is when the previous coat is just beginning to get out of tack (approximately 35 - 50 minutes). This recoat schedule will assure good bonding to the previous coat. If a coat has dried for 24 hours, then lightly sand before recoating.

Performance & Durability

This product forms an exceptionally tough and durable finish coat. This acrylic urethane coating is resistant to color change and is recommended for use on exterior surfaces.
